# Update From The Legislature

The Legislature began the 2006 session on January 4<sup>th</sup>. This year will be very busy since this is the short 60-day session and we are facing many contentious issues. My top legislative priority since being elected in 2004 has been the repeal of the sales tax on home repair labor. I have introduced LB 967 which would completely repeal this tax and the Governor has included my repeal of this tax in his tax cut proposal. At this time, there are 32 Senators who have signed onto the repeal legislation. While the prospects of getting this bill passed are good, we have a long way to go and I will need to have your continued support if we are to be successful. Please continue to contact **Senator Dave Landis**, Chairman of the Revenue Committee at <u>dlandis@unicam.state.ne.us</u>.

Other issues are going to take up a great deal of the Legislature's time including the One City, One School District Plan, concealed weapons, other tax cuts, and the possible impeachment of University of Nebraska Regent David Hergert. I have introduced bills dealing with the reorganization of the Health and Human Services System, early childhood education, tougher penalties for sexual offenses against children, sex offender restrictions, and registration and a pregnancy pre-existing condition exemption for health insurance.

# GPNA Seeks 501 (c)(3) Status

Federal tax law provides tax benefits to nonprofit organizations recognized as exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code. The benefits of having 501(c)(3) status include exemption from federal income tax and eligibility to receive tax-deductible charitable contributions. Individual and corporate donors are more likely to support organizations with 501(c)(3) status because their donations can be tax deductible. While memberships to GPNA will not be tax deductible, donations above and beyond membership dues will be under this designation.

# City Of Omaha Bulky Site Drop-off Program - 2006

The City has contracted with **River City Recycling** to cost-share on bulky items delivered to them by Omaha residents (NO cost-sharing on yardwaste or tree debris)

#### River City Recycling Address: 6404 South 60 Street (between Q & Harrison) Phone: 731-0414

Each Omaha residence is eligible for up to 4 (four) loads per calendar year under the cost-sharing program.

Drive a personal vehicle or bring the registration from a personal vehicle to prove you are a resident of the City of Omaha or other documentation that may prove you are a resident. RCR can also call 444-5238 to verify if an address is within Omaha city limits.

The resident pays a \$7.00 administrative charge to sign up for the 4-part coupon.

Coupons can be used to deliver the first load if items are brought on the sign-up visit.

Coupons are good for: 4 deliveries (one coupon for each) from automobiles and passenger vans (not to exceed 2 cubic yards) or 2 deliveries (2 coupons for each) from pickup trucks, cargo vans, or trailers (not to exceed 5 cubic yards each).

For car, truck, or trailer loads exceeding these limitations the contractor may require additional payment by the resident of up to \$6.00 per additional cubic yard

For dense or overweight materials (in excess of 1750 lbs.) the contractor may assess a surcharge to the resident of up to \$15.00 per additional 1000 lbs.

There is a \$10.00 per item surcharge for freon-containing devices (eg. air conditioner, refrigerator, freezer)

River City will accept the following types of materials for a fee to be paid in total by the resident (call ahead, 731-0414, if you have questions about what they will accept):

- Tires

- Yardwaste & tree debris

- Concrete, rock & construction materials

River City will NOT accept liquids OR hazardous waste OR railroad ties

## Free Tax Help Available Now

The site for the annual free tax assistance is the Lay Apostolate Center at St. Cecilia's Cathedral, 40th & Webster St. Tax help will be available on Mondays from 1:00 to 3:30 p.m., Wednesdays from 6:00 to 7:30 p.m. and Saturdays from 10:00 to 11:30 a.m. through the tax season. Everyone is welcome! IRS representatives will provide free tax help for our neighborhood for the 12th year in a row. Processing of basic tax returns and electronic filing will be available. No appointment is necessary; walk-in appointments only. Please call Jackie at 551-3629 for more information. To be able to provide assistance, persons will need to bring:

- 1. Valid Picture I.D.
- 2. Copies of ALL W-2, 1098, 1099 Forms and the amount of other income received by you and your spouse
- 3. Tax Identification Number (example: Social Security Number, Individual Tax Identification Number) for you, your spouse and any others shown on the tax return.
- 4. Provider's address and Tax Identification Number for Child/Dependent Care Credit
- 5. Form 8332 or copy of divorce decree for noncustodial parent claiming child
- 6. Proof of Account Number and Routing Transit Number of the financial institution for direct deposit into a savings or checking account.
- 7. Copy of prior year's tax return, if available.

## Death By Chocolate

Chocolate, a delight to some and a passion to others, is a poison to dogs and can easily be lethal. The toxic substance in chocolate, which dogs do not safely metabolize, is called theobromine. Baking chocolate contains the greatest concentration, then dark chocolate, then milk chocolate; all are dangerous.

If you think your dog may have eaten chocolate, do not wait for her to show symptoms: rush her to the veterinarian or animal emergency hospital immediately, for prompt treatment increases the chances of survival. Symptoms of chocolate poisoning may include violent shaking, disorientation, legs buckling, etc.

Please know, too, that onions and grapes are also poisonous to dogs. Chocolate is also dangerous for cats, and aspirin is poisonous to cats. Our companion animals may be like us emotionally, but they are quite different from us physiologically.

In Omaha, emergency critical care is available after-hours, weekends, and holidays from **Animal Emergency Cinic**, 339-6232, 9664 Mockingbird Drive, located 2 blocks south of 96th & L, then 1 block west.

Lastly, please remember that antifreeze, fatally poisonour to dogs, cats, (and small children), has a sweet taste that is very attractive, so always store it properly, clean up spills, and dispose of it safely, so that it can't hurt urban wildlife.

#### Omaha Neighborhood Scan (ONC) Update

Eleven properties out of nineteen cited for four or more "major code violations" during the ONS who did not address code infractions were turned over to the City of Omaha Planning Department this month. One housing inspector is handling all eleven properties. ONS submitted the list of the violations for each property, including photo documentation as well as the letter/material and relevant dates sent to each property owner. The inspector will look at each property in the field and then make decisions on the course of action to take.

The GPNA continues to scan all properties within the Association's boundaries. We anticipate partnering with Joslyn Castle Neighborhood Association and ONS in an effort to define programs to address ongoing code violations.
