Tyronda was recognized on September 10 for her commitment to violence prevention and changing lives! Thanks Tyronda for helping YouTurn fulfill its mission of helping youth "Make A 180 Against Violence". The organization is a community-based "movement" committed to ending youth violence and works one-on-one with the highest risk adolescents and young adults, 12 to 25+ years of age, that are negatively impacted by violence in the community. YouTurn offers support and resources to break the cycle of poverty, reduce violence and trauma, and promote positive behavior change leading to resiliency, healthier families, and safer communities.

Tyronda is a longtime Gifford Park resident and GPNA volunteer for many of our neighborhood programs and events including Easter egg Hunt, neighborhood & park cleanups, youth garden, Adventure Playground, youth tennis, youth soccer, youth basketball, Yates Community Center, Gifford Park Elementary School, holiday banquet, Slip'N'Slide, 33rd Street Block Party (last year's parade and hoop-it-up), and is a great neighbor keeping an eye on the neighborhood, especially our youth and more vulnerable folks. Tyronda is the type of neighbor who will call to check on how you are doing for no particular reason, because she genuinely cares. # "Just one more thing: Give us Yates—we will know what to do with it for everyone."


Early in September the Yates Illuminates community proposal, backed up by the Weitz Family Foundation, was submitted to the attention of Omaha Public Schools, to purchase the Yates building and to continue its use as a community center with an educational purpose.

The speakers at the OPS Board of Education Meeting on Monday, September 21, were all great and made the case for the Yates Illuminates proposal. Senator Sara Howard spoke about the effort the community put in this project and the importance to have such an education center serving the entire Omaha community to continue the wishes of the Yates family for years to come. Julie Smith described the science behind the visioning sessions conducted for the planning. Marie Hélène André made the case for the continuation and expansion of over thirty years of youth and multi-generational programming into a brick and mortar setting year round. Rose Carlson spoke on behalf of Eva Swanson who unfortunately couldn't come in person: Eva went to Yates school as a child; she insisted that it is thanks to the neighbors' commitment since the 1980s that the neighborhood is what it is today--a safe place for everyone--, and it is this kind of commitment that will make the Yates Illuminates project a success. Pam Font-Gable highlighted the importance of such a community and education center to support New Americans as they make Omaha their permanent home. Dr. Van Bawl Kan spoke about how Yates programming helps himself and his community overcome literacy challenges, and learn and improve English skills to become contributing citizens. Yohana Vanero impressed everyone when she told her story as an immigrant who needed to learn English, and she insisted that closing Yates would mean shutting down thousands of dreams of qualified professionals wanting to contribute their best to the United States. Alyssa Stanley thanked OPS for giving us the beautiful Gifford Elementary School, before asking for 'just one more thing': that by giving us Yates, OPS shows our kids that they are loved

not only between 8 am and 3 pm, but all the time, and even after high school graduation, for life, as lifelong learners along with all of us. 'We will know what to do with it for everyone.' Witney Stanley explained how we would embrace the sense of community that exists in the neighborhood and at Yates, and spread the love of learning to people allover Nebraska. Kevin Lawler mentioned he's never seen a project as innovative as this one, and he's excited to bring the storytelling work of Great Plains Theater Commons to Yates Illuminates.

At the last minute we learned that the vote wouldn't take place as early as we had hoped. The Yates building sale may be on the agenda of an OPS Board of Education meeting mid-November.

Now is the moment! Let's all speak up and be counted! Between now and then there will be three more meetings when we would appreciate speakers in support of the Yates Illuminates proposal, for Monday, October 19, November 2, and November 16. Please also contact your OPS Board of Education elected member, and ask your friends living across all of Omaha to do the same with theirs. Call or email your OPS elected official and tell them that you too would like to learn forever at the Yates Illuminates community center. #### **Boundaries**

Good fences make good neighbors. One man's ceiling is another man's floor. One man's liberty ends where another man's begins. Or Ann Landers' famous "MYOB".

All different ways of saying that people need to respect boundaries.

On a local website, one poster complained about what is permitted and what is not. City laws usually provide guidelines on what is allowed.

A recent posting discussed noise limits. Maybe worth quoting those limits, from city ordinances:

-"Sec. 17-3. - Volume control.

No person shall play, use, operate or permit to be played, used or operated, any radio, tape recorder, cassette player, compact disc (CD) player, or other machine or device for reproducing sound, if it is located in or on:

- (1) Any public property, including any public street, highway, building, sidewalk, park or thoroughfare; or any motor vehicle on a public street, highway or public space unless the volume of amplified sound shall be so controlled that it will not be audible for a distance in excess of one hundred (100) feet from the source and so that the volume is not unreasonably great and the noise, raucous, jarring, disturbing or a nuisance to persons within the area of audibility; or
- (2) Residential property, whether a unit of a multiple-family residential dwelling or a single-family dwelling structure, unless the volume of amplified sound shall be so controlled that it will not be audible in any adjoining unit. Provided, however, that actual notice from the occupant of the adjoining residence to the occupant of the property containing the source of amplified sound shall be a necessary element under this subsection."

In simple terms, you have a right to listen to what you want to listen to. But your neighbor has a right NOT to listen to it.

Everyone has a right to post political signs

on their property, within reason. And others do not have a right to deface or remove those signs if they disagree with the message. Differences of opinion are normal, imposing opinions on others is not.

You have a right to own a dog. But you have a responsibility to see that the dog does not disturb the neighbors with barking, to confine your dog on your property, and to clean up after your dog if you choose to take it off your property.

Public parking is just that, public. You do not have a right to convert public parking for your private use. Vehicles must be moved periodically, and unregistered vehicles may not be parked on public streets. No-parking areas are defined to promote traffic flow and traffic safety. Parking in noparking zones, even temporarily, can create traffic hazards, especially on our narrow neighborhood streets.

Most conflicts between neighbors can be avoided, if appropriate boundaries are recognized and respected.

What follows expresses my humble opinion and my feelings about Tyler Magnuson's editorial in the July newsletter. It is slightly adapted from the original response I sent to Tyler before the newsletter was published.

Because of who I am, my upbringing and my very personal experience, I have been a witness with a special perspective on the events. I want to remind you that English is my third language, and it is not easy for me to express how I feel about what is happening. I am not used to speaking/writing about my own personal feelings, not even in French...

The past months have been hard on each and all of us; the social upheavals have shattered our beliefs and it is a time of great changes. We have entered uncharted territories.

I appreciate Tyler's wanting to change and improve things for populations who have suffered a lot and are still suffering from injustice and discrimination. However, I feel some categories of people 'at risk' of racism, discrimination and injustice are forgotten in the editorial. The community is unsafe not only for BIPOC, it is also unsafe for those who do not 'belong': those who look different than the vast majority, those who come from elsewhere, those who have an accent or do not speak English fluently.

I am white, yes, and I am a woman.

As long as I remain silent, I am 'safe', but as soon as I start speaking, people notice my accent (some may say it is cute), and I subject myself to lack of respect, discrimination, unwanted questions/comments/insinuation, or even worse, some people just ignore me. I have learned to cope with it, I have learned to make fun of my own accent (and somehow to be proud of it), but it hurts, and I am sometimes afraid to speak in public, or

to have to justify myself. My husband and I have had encounters with police/immigration officers or safety officers, and I was scared: although we are both white and we are both educated, we sometimes didn't feel safe!...

I have also noticed that deep discrimination exists among people of the same race, and I could tell you more about that.

Until recently, I thought Gifford Park was the place I could call home, which is really hard for me: I am Belgian but born and raised in Africa, educated in Belgium and the Netherlands; I also lived and worked in Brazil, and I end up in Gifford Park, Omaha as a first-generation American. Where do I really belong? Where is 'home'? Wherever I go, I am 'the foreigner', I do not really belong anywhere, just because I was somehow 'privileged': to be white growing up in Africa, to have grown up in Africa compared to other Belgians, to be European in Brazil... and now to be 'a white property owner' in Gifford Park?

Since I arrived in Omaha, I have tried to use my own experience to help those whose voice is rarely heard, both at work and in the neighborhood. Integrating into a new country, a new culture, a neighborhood takes time and a lot of personal effort. When we moved to the neighborhood, nobody came to welcome us, we had to consciously take steps to meet people and introduce ourselves. We soon got the newsletter announcing the next general meeting and decided to take the first step and attend that meeting, the end-of-the-season potluck in the community garden, and other events to get to know neighbors. We were responsible for our own integration in the neighborhood and in the community. I now realize that being an active member of the neighborhood

association, sitting on the board and even being its President doesn't mean I am an integral part of this very community... How disappointing! How much more do I need to do after 7 years in the neighborhood to really be a member of the community beyond my differences and so-called privileges?!

I agree a lot more needs to be done to really have each and everyone feel welcome and valued in this neighborhood.

More diversity is certainly needed at all levels of GPNA, starting with the Board. However, we have tried in the past to recruit members with diverse backgrounds to represent their community and they have respectfully declined the invitation for personal reasons. Forcing diversity on the Board may not lead to the expected results to really represent our community. We must first define what kind of diversity we want, and recognize it may somehow already exist in ways we didn't think about.

Finally, in this time of major changes, it is of utmost importance to have a message of healing and unity rather than a divisive, controversial, antagonizing and blaming speech that may lead to negative reactions and resentment rather than appeasement. We also have to look at the long-term effects of our messages and articles, who they will reach and how they will be perceived, what the consequences will be not only for our neighborhood, but also for the bigger projects GPNA has undertaken to benefit the larger community of Omaha in its diversity, and how those very messages could jeopardize them.

# **Parking Violations**

As children return back to school it is a good time to remind neighbors that vehicles should not be parked on sidewalks. It is, of course, illegal. In addition, it is inconsiderate to pedestrians. As a neighborhood, we try to be pedestrian friendly. Please leave sidewalks unobstructed, so the many walkers and children can use them. In addition, where there are sidewalks, and that is almost everywhere in our neighborhood, we would ask that pedestrians use the sidewalk, rather than walking in the street, obstructing traffic and risking injury. Parking violations continue to be a big problem. In many cases, legal on-street parking is available close by. In some cases, as in that shown in the photo, there is sufficient room to pull forward off the sidewalk and onto the driveway. So, we would appeal to drivers to please make the effort to keep sidewalks clear.

eager to encourage. As a regular
customer at Myrtle & Cypress, he
often shared ideas and generously
offered to connect us to people
he knew who could help us out.
Daryl was gentle, perceptive and

homeless community in the Gifford
Park area.

Daryl was a veteran of the Iraq War who preferred to stay outdoors. When interviewed earlier this year about his experience of the Pandemic, he said that it was disappointing that it was happening and that he felt safer living in the open air.

Daryl knew suffering deeply, yet he wore an eager smile. He always carried hope, despite his many


traumas and addictions. He taught us the joy and power of friendship, the gift of each new day, and the high cost of broken systems and injustice.
